This MEMORANDUM OF UNDERSTANDING (the "MoU") FOR ACADEMIC COOPERATION AND EXCHANGE made and entered into on this 8<sup>th</sup> day of October 2019 (the "Effective Date") between:

Matsyodari Shikshan Sanstha Jalna (herein after referred as MSS, Jalna), having its office at Near Motibag, Railway Overbridge, Jalna, Maharashtra - 431203

**Institute of Chemical Technology, Mumbai** and its campuses, at Jalna (ICT, Mumbai Marathwada Campus, Jalna) and Bhubaneshwar (ICT, Mumbai Indian Oil Odisha Campus Bhubaneshwar) (hereinafter referred to collectively as ICT) having its main campus at Nathalal Parekh Marg, Matunga (East), Mumbai, Maharashtra 400019.

MSS, an established organization in Jalna District engaged in the field of education and running College of Engineering and Technology along with the senior & junior colleges in other faculties under the leadership of Hon. Er. Rajeshbhaiya Tope (Ex. Minister of Higher and Technical Education) who was also associated with ICT Mumbai. During his tenure, Matsyodari Shikshan Sanstha, Jalna (MSS) was established under the adage of "Shahane Karuni Sodave Sakaljan".

MSS is running more than 64 units all over the Jalna district including 17 senior colleges, 9 junior colleges, 22 High schools, 9 Primary schools, 5 MCVC colleges, MBA college, Polytechnic and Engineering College. MSS has a vision to enable their

Students to become responsible citizens, adept to face the present situations and future challenges in a fast, rapidly changing world by incorporating best of academics and values. MSS has been awarded as Best Shikshan Sanstha by Government of Maharashtra.

MSS, Jalna runs College of Engineering and Technology (MSSCET), Jalna which has good infrastructure with good workshop facility and well-equipped laboratories with qualified staff. MSSCET Jalna has good relations with industries; students undertake in-plant training and 75% of final year students undertake industry sponsored projects. The students also undertake projects sponsored by MASSIA & GIZ. Institute also participated in National level carting events, SKDC Hyderabad and BFKCT Coimbatore with all India rank of 8. MSSCET is NAAC Accredited with B+ Grade. MSSCET Jalna and ICT Jalna currently are working in collaboration with each other in academic activities.

1. Whereas ICT known for its valuable contribution in the field of Chemical Technology at National and International level through the involvement of its stakeholders (students, faculty, alumni and entrepreneurs) and whereas MSS, an established organization in Jalna, are willing to facilitate cooperative activities in academics and research, co-hosting national and international conferences/seminars/ workshops, educational fairs, exchange of faculty, post graduate students and research scholars at any of their branches. Cooperative activities may involve programs in areas like faculty training, skill development programs, student internships, collaborative masters and Ph.D Programs, and collaborative research and/or teaching.
2. MSS and ICT agree to facilitate, where feasible (financially or otherwise), short-term to mid-term exchange of faculty, post graduate students and research




scholars at any of their branches.

3. Sabbaticals and visiting professorships may be added when agreed and approved by both the institutions.
4. Regarding collaborative research under the authority of this MoU, the institutions will, on a project-by-project basis enter into a specific agreement to clarify and define the nature, extent and terms governing the project. This includes intellectual property terms based on respective Institutional intellectual property policies and collective agreements.
5. Academic facilities provided to visiting faculty members may vary among departments. The respective department chair or head, in consultation with designated faculty member, will make such arrangements.
6. All activity details shall be agreed upon in writing prior to implementation through a signed document.
7. Specific terms of agreement providing for transfer of information, faculty, and research scholars for education, research or related activities will be proposed by the two Institutions through their respective faculties and units, in concurrence with recommendations of the designated offices.
8. Prior to finalizing individual visits, representatives at both institutions shall secure approval from their respective department heads, dean, and designated administrative officers.
9. The two institutions may designate a 'contact person' from each of its branches/institute to facilitate communication and monitoring the mutual activity.
10. The purpose of this MoU is to express the intentions of both the institutions and is not intended to be legally binding on either Institution.
11. For problems/disagreements arising out of conditions not covered by this MoU, both Institutions agree to refrain from unilateral actions and to consult and negotiate for mutually agreeable decisions.
12. It is recognized that the implementation of this MoU will in every case be dependent upon the availability of necessary resources, either from within the institutions or from external sources.
13. Any clause or article of the MoU may be modified or amended by mutual written agreement between ICT & MSS.
14. The MoU, valid for 5 (five) years from the date of signing, can be mutually extended for additional three years through a signed document by the two institutions through their representatives.

3. To get recognized as a teaching institute by other institutes or universities like College of Physicians and Surgeons, National Board etc.
4. To conduct workshops, seminars, continuous medical education and conferences on subject related to psychiatry.
5. To prepare and distribute educational material in order to update psychiatry knowledge at all levels from lay person to experts, along with other research activities.
6. To start and provide Rehabilitation Services to Psychiatric patients including patients with Substance Use Disorders (addicts).

In consonance with these aims and objectives Manas Hospital and De-addiction Centre, Jalna has been undertaking various educational and awareness activities at Manas Hospital's premises.

Manas Hospital & De-addiction Centre is a well-equipped psychiatry hospital established in the year 2015 providing range of psychiatric treatment such as OPD, IPD, ECTs, Behavior Therapy and Psychotherapy, Psychometric Testing, De-addiction Treatment, Rehabilitation, Child Guidance etc. It also provides facilities like library and state-of-the-art lecture hall to conduct educational activities.

Expertise and guidance in the field of psychiatry is always extended to the students by Consultants and Therapists of the Hospital.

**Matsyodari Shikshan Sanstha's Ankushrao Tope College, Jalna (MS)** is a NAAC reaccredited 'A' grade college. The college has UGC-CPE status. The college is well equipped with all necessary educational facilities along with ICT based classrooms, spacious Library, research centre in six subjects, counselling centre, two girls' hostel, indoor sports hall, solar system for electricity etc.





2. If any collaborative projects and/or funding proposals are undertaken, a detailed collaboration agreement will be negotiated between the two organizations.
3. Both the organizations agree that all financial arrangements necessary to implement this MoU or any subsequent agreement must be negotiated according to the regulation of each institution and depends on the availability of funds. Both the institutions recognize that:
- a. this MoU establishes a foundation of mutual understanding and interest and does not itself entail any financial obligations for either institutions;
  - b. this MoU will take effect from the date of its signing and shall be valid for the period of five years from that date, unless terminated earlier upon six months notice by either institution;
  - c. this MoU may be revoked or modified by mutual agreement between the institutions and may be extended beyond its initial five-year term by mutual agreement.

This MoU is being signed on 26<sup>th</sup> August 2019 and will stand effective from the same date.

  - c. this MoU may be revoked or modified by mutual agreement between the institutions and may be extended beyond its initial five year term by mutual agreement.

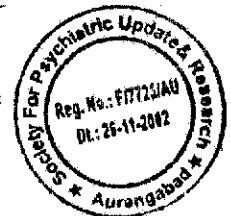

efforts to complete or terminate existing projects or engagements without substantial prejudice to the other party.




